DECLARATION OF CONTROLLED AREA

NOTIFICATION

Dated Quetta, the 30th May, 2018.

Notification under Article 6 read with Article 3(k), 14 & 19 of the Defence Housing Authority (DHA) Act (Act No. XI of 2015) dated 2 October 2015

1. In exercise of the powers conferred by Article 6 read with all other enabling provisions of the Act, and in order to carry out the purposes of the Act, with the consent and approval of Government of Balochistan, the Executive Board of Defence Housing Authority Quetta is pleased to declare limits/ boundaries of Controlled Area prospectively to be acquired for carrying out planning and development of its projects for public purpose i.e. "Specified Area to be." The limits of the area for future planning/ development for DHA Quetta are given herein below:-

“Declaration of Area”

- a. Area bounded by /partially comprising Mouzas of Kuchlak Circle namely, Kateer (excluding built-up area of Kuchlak in eastern half). Samali, Gadazai and Malazai (including unsettled area east/ northeast uptill offshoot of Koh-e-Takatu).
 - b. Area bounded by/ partially comprising Mouzas of Baleli Circle of Distt Quetta namely Karak, Tarkha Gordat Singh, Mehtarzai (incl part of Mouza Regi which is West of Mouza Mehtarzai and North of Samungli Road), Chashma Baleli (excluding area South and East of Baleli Railway Station) and Chashma Achozai (excluding populated area south of Northern By pass).
 - c. Area Mouza Nauhisar (Nauhisar Circle) which is North of Samungli Road.
 - d. Area bounded by/ partially comprising Mouzas of Durrani-2 Circle of Distt Quetta namely, Sra Ghurghai (excluding built up area South of Northern Bypass and including unsettled area on North up till foothills of Koh-e-Takatu), Sra Khula (excluding populated/ Cantt area on South), Hanna (Khushkaba Shumali & Khuskaba Janoobi) and Tor Ragha including adjoining unsettled areas of the valley on the North/ Northeast astride Shaban Road up till Shamozai Dam.
2. This Notification is issued for the purpose of conveying the intention of DHA Quetta, regarding acquisition of land within the Controlled Area, to all whom it may concern. No master planning or development scheme shall be prepared by any local body or agency for the specified area without prior consultation with, and approval of DHA Quetta.

3. The management of the Authority, through this notification, invites persons, local bodies or agencies/ organizations interested for conveyance of land to DHA Quetta or synchronization, merger or amalgamation of all adjoining housing schemes or cooperative housing societies, whether developed or under development, and duly approved by QDA, after necessary agreement or adjustment within future planning of DHA Quetta projects.
