- Installment would be payable Quarterly (10<sup>th</sup> of January, 10<sup>th</sup> of April, 10<sup>th</sup> of July and 10<sup>th</sup> of October). Late payments would incur penalty (details at para 8 below).
- 4. The applicant shall make down payment within the period specified in the DEMAND NOTICE that would be issued to successful applicants. If the applicant fails to pay the dues within specified period mentioned in the DEMAND NOTICE, the application will be liable to be cancelled due to non-payment. Advance Notice in this regard would be served prior to cancellation.
- Default in payment of *three consecutive* or *any four installments* will result in cancellation of plot. The amount deposited by the applicant will be refunded after completion of the installments payments as notified with 20% deduction of deposited amount.


